STUDENT EXPECTATIONS AND CLASS POLICIES

We would like to thank you for choosing us in helping you grow in your development and appreciation of dance. We recognize the importance of this combined involvement as we reach toward your goals. Communication is an important factor in any partnership. We are committed to being open and fair. We are excited about making an impact on young dancers and developing a positive this relationship with all of our members. Please read and initial the following student expectations and class policies.

Student Expectations

Precision Dance Company is a positive, non competitive dance environment, where aspiring dancers of all levels, backgrounds, experience, etc., can train in various styles of dance. All students are expected to be well-behaved, courteous, honest, and respectful of all staff, students, guests and members of the Precision Dance Company to maintain this environment. Poor attitudes, uncooperative behavior, negative comments, disrespect and gossip will not be tolerated. Any parent or student exhibiting these attitudes will be asked to leave. Precision Dance Company reserves the right to refuse or terminate service to any parents and/or student that display these characteristics and/or behaviors. Parents will be required to pick up their child immediately in the case of continual disciplinary problems.

Guests of students and parents are allowed to observe classes in the designated patio so long as it is not disruptive to our neighbors, students or classes.

The dance studio will be used for dance and technique training. Running, horseplay, rough housing, loud talking, etc. is not allowed. Students will be expected to respect the dance environment in their behavior and in their conversations.

Students are expected to assist in maintaining the cleanliness of the dance space by cleaning up after themselves, keeping their belongings organized and neat, and adhering to the bathroom use policies.

Precision Dance Company is not responsible for lost/stolen items or items left in the dance studio after class. Students should not bring valuables to the studio at any time and should keep their belongings in one place.

Precision Dance Company does not require its students to wear specific dance attire, however, students must cover dance clothes with appropriate "cover up" clothing (i.e. sweatpants, sweatshirt, jacket, jazz pants, etc.) when entering and exiting the studio. Student dance attire during class must also be age appropriate and in good taste. Precision Dance students are of all ages and we must ensure that the dance environment is not offensive to anyone, is respectable and promotes a positive image for young dancers. Jewelry with the exception of stud earrings is not allowed to worn during class. Students will be asked to remove all jewelry prior to entering class.

Under no circumstances is gum allowed in the dance studio. Students caught with gum will be assessed a \$10.00 penalty fee for each offense.

LIABILITY RELEASE AND WAIVER

I understand that activities in the Precision Dance Company summer camp include occasional off-site field trips which my child has my permission to participate in. I understand that, for field trips not within walking distance, my child will be transported by an insured and licensed driver over the age of 25. Most field trip drivers will be volunteer parents and/or Precision Dance Company staff.

I understand that no alteration of the terms of this agreement shall be valid unless made in writing and signed by myself and an authorized representative of the Precision Dance Company, and no oral understanding or verbal agreements shall be binding on the Precision Dance Company or myself.

I grant permission for Precision Dance Company to use my child's likeness in photograph (s) and /or video footage in any and all kinds of its publications, promotional items, website and/or social media accounts without further authorization, now or in the future, in perpetuity. I will make no monetary or other claim against the Precision Dance Company for the use of the photograph(s) and/or video footage.
